## Delilah's 12 Stockings of Christmas Sweepstakes OFFICIAL RULES

PROMOTION ENTRY PERIOD: Delilah's 12 Stockings of Christmas Sweepstakes (the "Sweepstakes") begins at 12:00:00 a.m. Eastern Time ("ET") on November 24, 2021 and ends at 11:59:59 p.m. ET on December 22, 2021 (the "Sweepstakes End Date") (collectively, the "Promotion Entry Period"). All entries must be received during the Promotion Entry Period. The Sponsor's computer is the official time keeping device for this Sweepstakes.
- **ELIGIBILITY**: Sweepstakes is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years of age or older as of the date of entry. 4.
