

## **Delilah's Mother's Day Las Vegas Residency Flyaway Sweepstakes (the "Sweepstakes") Official Rules**

**1. ELIGIBILITY:** The Sweepstakes is open only to individuals who are legal residents of the forty-eight (48) contiguous United States or the District of Columbia, who are twenty-one (21) years of age or older at the date of entry (the "Entrant").

The Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Void in Alaska, Hawaii, outside of the United States, and where prohibited or restricted by law.

Entry Limit: One (1) entry per person/household per day during the Sweepstakes Period. For purposes of this Sweepstakes, a "Day" shall be defined as each calendar day, beginning at 12:00:00 a.m. ET and ending at 11:59:59 p.m. ET on that same day.

**3. HOW TO ENTER:** During the Sweepstakes Period, visit <http://www.Delilah.com> and click on the entry form. Then, complete and submit the entry form with all requested information (including your name, email address, phone number, date of birth, and/or any other information requested by the Sponsor) to receive one (1) entry into the Sweepstakes. Entries must contain all information requested to be valid.

### **Bonus Entries:**

Upon completion of entry into the Sweepstakes, Entrants may also click on the bonus entry button(s) (the "Action"). Note that this Action MUST be done through the bonus entry button on the online entry form. If this Action is taken through any other means, you will not receive a bonus entry for that Action.

**5. PRIZE(S); APPROXIMATE RETAIL VALUES ("ARV"); AND ODDS:**

**ONE (1) GRAND PRIZE:** A three (3) day/two (2) night trip for winner and (1) eligible guest (together, the "Attendees") to attend a *New Kids on The Block: The Right Stuff Las Vegas Residency* concert on June 19, 2026 in Las Vegas, Nevada (the "Event") (collectively, the "Trip"). The Trip includes:

- Round trip coach air transportation for the Attendees from the major airport nearest the winner's residence to the major airport nearest Las Vegas, NV (as determined by the Prize Provider in its sole discretion);
- Two (2) nights standard hotel accommodations at Park MGM Las Vegas (single room/double occupancy/room and tax only);
- Two (2) *Barstool Seats attached to the Stage* tickets for the Attendees to the Event (seating as determined by the Prize Provider in its sole discretion);

Odds of Winning: The odds of winning the prize depend on the number of eligible entries received.

No more than the advertised number of prizes shall be awarded. The prize is subject to certain terms and conditions as specified herein. THE ARBITRATOR MAY NOT CONSOLIDATE OR JOIN THE CLAIMS OF OTHER PERSONS OR PARTIES WHO MAY BE SIMILARLY SITUATED. DO NOT ENTER THIS SWEEPSTAKES IF YOU DO NOT AGREE TO HAVE ANY CLAIM OR CONTROVERSY ARBITRATED IN ACCORDANCE WITH THESE OFFICIAL RULES.

**13. MISCELLANEOUS:** Sponsor reserves the right to determine eligibility should special circumstances arise and all decisions made by Sponsor are considered final and binding. Sponsor disclaims any responsibility to notify Entrants of any aspect related to the conduct of the Sweepstakes.
